ORDER IN COUNCIL



IN THE ROYAL COURT OF THE ISLAND OF GUERNSEY

The 9th day of December, 1980 before Charles Keith Frossard, Esquire, Deputy Bailiff; present:—Stanley Walter Gavey, Esquire, O.B.E., Edward James Lainé, Esquire, C.B.E., D.F.C., Richard Alan Kinnersly, Richard Oliver Symons, Albert Richard McCartney Straw, Esquires, Frederick William Winslow Chandler, Esquire, D.S.O., D.F.C., Lionel Walter Sarre, Esquire, M.B.E., K.P.M., Donald Pescott Plummer, Esquire, Sydney Haydn Heard, Esquire, M.B.E., Brian Ernest Herbert Joy, Esquire, Charles Henry Hodder, Esquire, O.B.E. and Harry Wilson Bisson, Esquire, Jurats.

The Deputy Bailiff having this day placed before the Court an Order of Her Majesty in Council dated the 11th day of November, 1980, ratifying a *Projet de Loi* entitled “The European Communities (Amendment) (Bailiwick of Guernsey) Law, 1980”, the Court, after the reading of the said Order in Council and after having heard Her Majesty’s Procureur thereon, ordered that the said Order in Council be registered on the records of this Island and that an extract of this present Act, together with a copy of the said Order in Council, be sent by Her Majesty’s Greffier to the Clerk of the Court of Alderney and to the Seneschal of Sark for registration on the records of those Islands respectively, of which Order in Council the tenor followeth:—

PRESENT,

The Queen's Most Excellent Majesty in Council

WHEREAS there was this day read at the Board a Report from the Right Honourable the Lords of the Committee of Council for the Affairs of Guernsey and Jersey dated the 30th day of October 1980 in the words following, viz.:—

“YOUR MAJESTY having been pleased, by Your General Order of Reference of the 22nd day of February 1952, to refer unto this Committee the humble Petition of the States of the Island of Guernsey setting forth:—

1. That, in pursuance of their Resolution of the 28th day of May 1980, the States of Deliberation at a meeting held on the 31st day of July 1980 approved a Bill or “Projet de Loi” entitled “The European Communities (Amendment) (Bailiwick of Guernsey) Law, 1980”, which Bill is designed to apply to the Bailiwick of Guernsey, and requested the Bailiff to present a most humble Petition to Your Majesty in Council praying for Your Royal Sanction thereto.
2. That the States of the Island of Alderney at a meeting held on the 3rd day of September 1980 considered the said Bill or “Projet de Loi” when a Resolution was passed agreeing to the application of the same to Alderney.
3. That the Chief Pleas of the Island of Sark at a meeting held on the 1st day of October 1980 considered the said Bill or “Projet de Loi”

when a Resolution was passed agreeing to the application of the same to Sark. 4. That the said Bill or "Projet de Loi" is in the words and figures set forth in the Schedule hereunto annexed. And most humbly praying that Your Majesty might be graciously pleased to grant Your Royal Sanction to the Bill or "Projet de Loi" of the States of Guernsey entitled "The European Communities (Amendment) (Bailiwick of Guernsey) Law, 1980" and to order that the same shall have force of law in the Bailiwick of Guernsey.

"THE LORDS OF THE COMMITTEE, in obedience to Your Majesty's said Order of Reference, have taken the said Petition and the said Projet de Loi into consideration and do this day agree humbly to report, as their opinion, to Your Majesty, that it may be advisable for Your Majesty to comply with the prayer of the said Petition and to approve of and ratify the said Projet de Loi."

HER MAJESTY having taken the said Report into consideration is pleased, by and with the advice of Her Privy Council, to approve of and ratify the said Projet de Loi, and to order, as it is hereby ordered, that the same shall have the force of Law within the Bailiwick of Guernsey.

AND HER MAJESTY doth hereby further direct that this Order, and the said Projet de Loi (a copy whereof is hereunto annexed), be entered upon the Register of the Island of Guernsey and observed accordingly.

AND the Lieutenant Governor and Commander-in-Chief of the Island of Guernsey, the Bailiff and Jurats, and all other Her Majesty's Officers for the time being in the said Island, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

PROJET DE LOI

ENTITLED

The European Communities (Amendment) (Bailiwick of Guernsey) Law, 1980

THE STATES, in pursuance of their Resolution of the twenty-eighth day of May, nineteen hundred and eighty, have approved the following provisions which, subject to the Sanction of Her Most Excellent Majesty in Council, shall have force of law in the Bailiwick of Guernsey.

1. In subsection (1) of section one of the European Communities (Bailiwick of Guernsey) Law, 1973(a) (hereinafter referred to as "the principal Law") immediately after paragraph (b) of the definition of the expressions "the Treaties" or "the Community Treaties" there shall be inserted the word "and" and the following additional paragraphs:—

- "(c) the treaty relating to the accession of the Hellenic Republic to the European Economic Community and to the European Atomic Energy Community, signed at Athens on the twenty-eighth day of May, nineteen hundred and seventy-nine; and
- (d) the decision, of the twenty-fourth day of May, nineteen hundred and seventy-nine,

of the Council of the European Communities relating to the accession of the Hellenic Republic to the European Coal and Steel Community;”.

2. (1) This Law may be cited as the European Communities (Amendment) (Bailiwick of Guernsey) Law, 1980.

(2) This Law and the principal Law may be cited together as the European Communities (Bailiwick of Guernsey) Laws, 1973 and 1980.
