## **The Alderney (Application of Legislation) Law, 1948**

**WHEREAS** it has been agreed between the States of Guernsey and the States of Alderney that financial and administrative responsibility for certain public services (hereinafter in this Law referred to as "**the transferred services**") in the Island of Alderney should be assumed by the States of Guernsey:

**AND WHEREAS** it has been further agreed between the States of Guernsey and the States of Alderney that the States of Guernsey shall be empowered to extend to the Island of Alderney such legislation as may be necessary or expedient for the working of the transferred services, and that certain taxes, licence fees, impôts and duties leviable in the Island of Guernsey shall be leviable by the States of Guernsey in the Island of Alderney:

**NOW THEREFORE** the States of Guernsey, in pursuance of their Resolution of the 5<sup>th</sup> day of November, 1948, and the States of Alderney, in pursuance of their Resolutions of the 16<sup>th</sup> day of July, 1948, and of the 27<sup>th</sup> day of October, 1948, have approved the following provisions which, subject to the Sanction of His Most Excellent Majesty in Council, shall have force of law in the Islands of Guernsey and Alderney.

### **Extension of enactments to Alderney.**

1. (1) The provisions of any enactment now or hereafter in force in the Island of Guernsey relating to any of the subjects set forth in the Schedule to this Law may be extended by Guernsey Ordinance to the Island of Alderney with effect from such date as may therein be specified not being earlier than the 1<sup>st</sup> day of January, 1949, with such exceptions, adaptations and modifications, if any, as may be specified therein, and any such Ordinance may be varied or revoked by a subsequent Ordinance.

(2) The concurrence of the States of Alderney in any Law

initiated by the States of Guernsey or any Guernsey Ordinance either of which relates to any of the subjects set forth in the said Schedule shall not be required for the effectual operation thereof in the Island of Alderney after the 31<sup>st</sup> day of December, 1948.

**Taxes, etc. to be leviable by States of Guernsey in Alderney.**

2. On and after the 1<sup>st</sup> day of January, 1949, the taxes, licence fees, impôts and duties (other than Tonnage Dues and Wharfage) leviable by the States of Guernsey from time to time in the Island of Guernsey shall be leviable by the States

of Guernsey in the Island of Alderney at the rates from time to time operative as regards the same in the Island of Guernsey and the product thereof shall accrue to the States of Guernsey, and the provisions of every Law from time to time in force in the Island of Guernsey and of every Guernsey Ordinance and Resolution of the States of Guernsey made in pursuance of any such Law and from time to time in force in relation to any such tax, licence fee, impôt or duty, shall extend so as to have effect in the Islands of Guernsey and Alderney as though those Islands were one:

PROVIDED always that any such Law or Ordinance shall have effect in the Island of Alderney subject to such exceptions, adaptations and modifications, if any, as may from time to time be specified by Guernsey Ordinance.

**Occupier's Rate to be leviable by States of Alderney.**

3. On and after the 1<sup>st</sup> day of January, [1987], the States of Alderney, for the purpose of raising revenue towards financing the services for which the States of Alderney will continue to be responsible, shall levy an Occupier's Rate in each calendar year at a rate [prescribed in respect of that calendar year by an Ordinance made by the States of Alderney before the commencement of that calendar year] and provision may be made by Alderney Ordinance for declaring the incidence of such Occupier's Rate and for providing for the collection thereof.

**Assessment of rateable value of real property in Alderney.**

4. Provision may be made by Guernsey Ordinance for empowering the States of Guernsey [Policy & Resources Committee], during such period or periods after the 31<sup>st</sup> day of December, 1948, as may, from time to time, be agreed between the States of Guernsey and the States of Alderney, to assess the rateable value of real property situate in the Island of Alderney and from time to time to rectify the assessment of the rateable value of any such property and for extending to the Island of Alderney the provisions of any Cadastre Law from time to time in force in the Island of Guernsey with such exceptions, adaptations and modifications as the Ordinance shall prescribe and any such Ordinance may be varied or revoked by a subsequent Ordinance.

**[No duty to value real property in Alderney from 1<sup>st</sup> January, 2008.**

**4A.** Notwithstanding section 4 and any Ordinance or rule made under it, on and from the 1<sup>st</sup> January, 2008 –

- (a) there is no requirement –
  - (i) for the record of assessments of rateable value made under the Alderney Rateable Values Assessment Ordinance, 1949<sup>\*</sup> to state the rateable value of any real property in Alderney, or
  - (ii) for any assessment of rateable value already stated therein to be rectified, and
- (b) there is no duty on [the Committee] to assess or determine the rateable value of any such real property for the purposes of the preparation or rectification of that record.]

**Conflict of Laws, etc.**

5. In any case where the law of the Island of Alderney is in conflict with any provision of a Law, Ordinance or Resolution, extended to that Island by or by virtue of this Law, the latter provision shall prevail.

**Amendment of Import Duties Act (Bailiwick of Guernsey), 1932.**

7. The Import Duties Act (Bailiwick of Guernsey), 1932, shall have effect henceforth subject to the following modifications –

For the definition of the expression "Appropriate Authority" therein contained there shall be substituted the following definition –

**"Appropriate Authority"** means the States Supervisor in the Island of Guernsey and includes his authorised subordinates."<sup>2</sup>

The provisions of section 2 of the said Act relative to the despatch of Orders made under that Act to the President of the States of Alderney, to the bringing of every such Order before the States of Alderney, to the postponement of the operation in Alderney of any such Order, to the cessation of operation of any such Order in Alderney, to the publication of Resolutions of the States of Alderney in relation to any such Order and to the duty of His Majesty's Greffier in the Island of Alderney to forward a certified copy of every such Resolution to His Majesty's Greffier in the Island of Guernsey, shall cease to have effect.

So much of sections 18 and 19 of the said Act as require the Appropriate Authority to make payments into the Revenue of the Island of Alderney or to credit any amount to the Treasurer of the States of Alderney shall cease to have effect.

For section 36 of the said Act, there shall be substituted the following section –

"**36.** Provision may be made by Guernsey Ordinance for the purposes of carrying this Law into effect throughout the Bailiwick."
